**Electrical Amendments Per Ordinance: 2017-26**

- (1) Minimum conductor size of all light and power circuits greater than 100 volts shall be no less than 12 AWG.
- (2) No Aluminum Conductor smaller than 2/0 shall be used in the city.
- (3) Armor Cable (Type A/C without an individual grounding conductor is prohibited.
- (4) An accessible means of service disconnect shall be provided at the exterior of all buildings or facilities, directly next to the service meter or entry of the service conductors.

**PLAN REVIEW FEES**

When the area of the proposed construction exceeds 300 S.F. (Gross) and a plan is required, a plan-review fee shall be paid in addition to the building permit fee.) Res. No. 2007-13 one-half of the building permit fee as set forth above (C. (2) Residential/ Commercial Construction Fees).

**RE-INSPECTION FEES**

Repeated failure to correct previously noted inspection items may result in additional Re-Inspection Fees of \$75.00 (Per occurrence) being charged to the permit application.
